It is generally believed that persons with disabilities can only handle simple tasks even they have good academic qualification.

Some employers are reluctant to spend time on training disabled employees. I have once worked in a large company but was assigned with general clerical duties only. I was not able to show my talents.

Sunny coached her with patience and encouragement, so that she has confidence to meet the work requirements and fully demonstrate her abilities.

Communication and acceptance among colleagues are also important. The company organises workshops to raise staff's awareness of inclusive workplace and key points to communicate with persons with disabilities.

Colleagues are also willing to coordinate with each other, such as using computer-configured instant messaging tools, lip-reading, body language or writing etc. We see no problem to communicate with Gigi.

She is brave to challenge herself and will not limit her progression even with her disabilities. She is willing to share her experience to promote inclusiveness.
