The Government provides a comprehensive range of affordable, accessible and quality health care services for women. The Government has since September 2001 ntroduced the Universal Antenatal HIV Testing Scheme, under which all pregnant women will receive HIV antibody test on a voluntary basis. The publicity materials are written in 12 different languages to facilitate promotion of the heme among people of difference races. The Red Ribbon ntre of the Department of Health also makes active efforts mote women's awareness of HIV/AIDS.



The Government in collaboration with other health care professionals have launched since 8 March 2004 a territory-wide Cervical Screening Programme, under which participants will receive a cervical smear test at a mere cost of HK\$100 (about US\$13) for preventing cervical cancer.


