**Queen Elizabeth Foundation for the Mentally Handicapped –
Application for Grants 2026-27**

This is to inform you that the Council of the Queen Elizabeth Foundation for the Mentally Handicapped (the “QEFMH”) is inviting applications for grants 2026-27 for promoting the welfare of persons with intellectual disability; helping persons with intellectual disability to live independently; equipping persons with intellectual disability with vocational skills to enhance their employment opportunities; catering for the special needs of the aged persons with intellectual disability; as well as improving the rehabilitation service for persons with intellectual disability in an innovative way.

There are three schemes under the QEFMH –

- (a) **“General Support Scheme”** includes minor capital works projects, home-based or community-based rehabilitation services for persons with severe intellectual disability, public education programmes, etc.;
- (b) **“Scheme to Support Persons with Intellectual Disability for Independent Living Facilities”** aims at improving the living environment for persons with intellectual disability and their independent living skills so that they can enjoy higher quality of living; and
- (c) **“Scheme to Support Aged Persons with Intellectual Disability”** aims at enhancing the rehabilitation services for aged persons with intellectual disability, providing a suitable environment for them for positive and active ageing. In recent years, the Council of the QEFMH has funded projects to provide screening services (including basic health check, vision, hearing, dental, orthopaedics and podiatric screening, etc.) for persons with intellectual disability, so that carers can identify early symptoms of ageing in persons with intellectual disability for proper follow-up and referral service.

Similar to previous years, projects with the following themes will be accorded a higher priority -

- (a) projects to strengthen early identification/intervention and to enhance learning experience;
- (b) projects to maximise development potentials to enhance employment opportunities and independent living skills and maximise potential through participation in arts and sports; and
- (c) projects to promote health awareness to alleviate early symptoms of ageing and other health-related problems and achieve positive and active ageing.

————— A Guide to Application for a Grant from the Foundation (the “Guide”) and an Application Form are enclosed. The Application Form can also be downloaded from https://www.lwb.gov.hk/en/servicedesk/forms/download_forms.html/ under "Download Forms" section. Please study the Guide carefully and note the following requirements when completing the Application Form –

- (a) Applicants should provide details on how the equipment to be acquired or services to be provided will be deployed to achieve the objective of the scheme concerned;
- (b) Applicants may submit supporting documents as deemed necessary to facilitate the Secretariat in processing the application. Moreover, the applicant may be requested by the Secretariat to provide supplementary documents and information for processing the application. Failure to provide such information within a reasonable time frame will impede the application processing;
- (c) For applications with the total amount of grant requested exceeding \$200,000, elements of “Sustainability” and “Dissemination” should be included. Examples are feasible plans to sustain the key activities after the completion of the project, deliverables/expected outcomes that have good value for sharing and/or high potential to benefit a wider reach of the community through different means; and
- (d) Specimen signatures endorsed by the head of the organisation/authorised persons on the application form will be used for verification of all application-related documents. Please inform the Council Secretariat of QEFMH in writing in case of any changes.

To facilitate the processing of applications, please send the signed hardcopy of the duly completed application form and supporting documents (where applicable) to the Council Secretariat of the Foundation by registered mail (Postal address : Secretary, Council of the Queen Elizabeth Foundation for the Mentally Handicapped c/o Rehabilitation Division, Labour and Welfare Bureau, 11/F, West

Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong), as well as the softcopy of the full set of documents by email (qefmh@lwb.gov.hk). **We accept the submission of application forms by registered mail ONLY. The closing date for submission of applications is 5 October 2026. The submission date of the application by registered mail is based on the postmark date.**

The time required for processing the applications varies depending on the number of applications received and the complexity of the applications. Hence, organisations are advised to exercise flexibility in designing the project schedule. **The Council of the Foundation will inform applicants of the application results in writing around end of March 2027. Applicants should not make any financial commitment for their projects before their applications are approved. The applicant shall bear all responsibilities for any financial commitment made without the approval of the Council of the Foundation.**
